



ANNOUNCEMENT OF SUB-REGIONAL PUBLIC MEETINGS

December 5, 2019

The Brazos G Regional Water Planning Group (Brazos G) will hold three (3) sub-regional public meetings within the Brazos G planning area on January 21, 22 and 23, 2020. These meetings are being held to obtain local stakeholder input on the 2021 Initially Prepared Brazos G Regional Water Plan (2021 IPP) prior to its submission to the Texas Water Development Board.

The Texas Water Development Board has completed population and water demand projections and the Brazos G Regional Water Planning Group has estimated available supplies to meet the projected water demands. Water management strategies will be recommended in the 2021 IPP to meet shortages whenever the projected demands exceed projected supplies.

These meetings will provide stakeholders with the opportunity to provide input on matters regarding available water supplies, projected water shortages (needs) and preferred water management strategies to address the needs identified in the 2021 IPP. Each meeting will focus on entities located in the specific counties identified for each sub-regional meeting, but representatives of entities outside the sub-region are welcome and will be accommodated.

Draft sections of the 2021 IPP, meeting agendas and related materials will be posted on the Brazos G website, located at www.brazosgwater.org, **not later than seven (7) days** prior to the first public meeting date, although this information may be updated after that time if additional data become available.
